2. THE THEME OF THE CALL FOR EDUCATION PROJECTS

The year 2026 marks the launch of ALTRAD Solidarity's call for projects **"No student left behind"**.

The endowment fund wishes to highlight projects of general interest related to the following themes :



- Combating school exclusion
- Making schools a place for everyone
- Combating school bullying
- Raising awareness about inclusion and promoting it
- Providing support to victims

This call for projects aims to support international, national, or regional projects of general interest and raise public awareness about the cause supported by ALTRAD Solidarity.

3. REGULATIONS

Article 1 : Application and Eligibility Criteria

Eligible projects must :

- Be recognized as being of general interest and have a selfless management structure
- Have independent governance
- Contribute to a fairer world for future generations
- Empower their target audiences
- Integrate and promote diversity, inclusion, and gender equality
- Demonstrate measurable and quantifiable impact
- Take place in a territory where our group operates
- Have fundraising costs below 30%
- Employ at least two staff members or have at least one year of existence
- Allow the involvement of our employees in solidarity actions where possible



Ineligible projects include :

- Religious projects
- Individual projects
- Organizations with political or religious missions
- Projects with commercial, promotional, or advertising purposes
- Organizations with recent negative impacts or that fail to meet UN-recognized ethical standards
- Organizations that do not comply with ALTRAD Group's compliance policy

Article 2 : Application file

Incomplete applications or those lacking all required documents will not be processed.

Application opening : **March 23, 2026, at 8:00 AM**

Application closing : **April 30, 2026, at 12:00 AM**

ALTRAD Solidarity reserves the right to request additional information or documentation from applicants at any stage of the selection process.

Selected applications will be reviewed by a jury comprising the operational team of ALTRAD Solidarity, the employee commission, and the board of directors. The jury will review the applications during **May 2026**. All candidates will be contacted in **June 2026**.

Article 3 : Evaluation criteria

Projects must meet eligibility criteria and fund an organization with **measurable and tangible impact**.

Priority will be given to projects allowing our employees to engage in solidarity efforts.

ALTRAD Solidarity will not fund advocacy actions and will pay particular attention to the following :

- Relevance to current challenges
- Number of beneficiaries
- Operational aspects of the supported project
- Feasibility
- Motivation

Article 4 : Awardees

Financial support from ALTRAD Solidarity for awardees will be formalized through a sponsorship agreement outlining the terms of support and obligations of both parties.

Supported projects will be monitored and evaluated by ALTRAD Solidarity throughout their implementation to ensure the proper use of funds and assess results.



Article 5 : Personal Data and Confidentiality

ALTRAD Solidarity processes your data in compliance with the GDPR effective May 25, 2018, and the amended French data protection law of January 6, 1978.

Your data will be handled confidentially and solely for the purpose of managing your application. Data will be retained for the duration of ALTRAD Solidarity's existence.
